#### Background:

The CMPVY Scheme was started in the year 2012-13 where beneficiaries were given subsidy to purchase vehicles to be used as tourist cabs. The scheme was re-structured in the year 2014-15 and subsidy were given under three components i.e value addition of Homestay, purchasing of adventure equipments and opening bakery/restaurants/food court.

While implementing the scheme, it was realized that few changes in the guideline is necessary for the successful implementation and monitoring of the scheme.

#### Objective:

The main objective of the scheme is to provide financial support to the beneficiaries in order to become self-employed in the field of tourism & hospitality.

# Scope of the scheme:

The scheme consists of three components where the Tourism Department proposed to provide back ended subsidy for:-

- Value addition to registered Home stay operators which includes renovation of 2(two)
  adequately sized well furnished rooms with attached toilet with shower, geyser and western
  toilet.
- 2. Purchasing of adventure equipments such as Zorbs, Quad bikes, rafts, kayaks, parachute, ATV etc. and developing a Camping Sites for electricity, water connection, Toilet etc. in areas where homestays and other accommodations are very few.
- 3. Opening of bakery/food court/restaurant/Food trucks.

# Fund Provision under the Scheme:-

As regards to fund provision, an amount of Rs 800.00 Lakhs(Rupees Eight hundred lakh) only have already been allotted by the Govt. for the purpose which is parked in Government account under Civil Deposit. The subsidy amount will be released to the beneficiaries through APEX Bank Ltd. After selection of the candidates by the committee, the amount shall be further released to the beneficiaries on back end basis.

## Mode of Subsidy:-

The mode of subsidy being disbursed:

- The maximum subsidy amount under the scheme will be 50% of the project cost or maximum of Rs 5.00 Lakhs.
- 2. Remaining amount of the project may be beneficiary's Contribution or by Bank Finance.
- 3. The beneficiaries shall complete the project within Six(6) months from the date of selection, failing which the quota allotted will be cancelled.

All the projects in the district will be monitored by the DA.
